It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for **the Supply, Installation, Testing and Commissioning of Ginger Factory Machinery & Equipment at Mamba Miamba Ginger factory in Same District, Kilimanjaro Region.**

The Board of Trustees of **LAPF PENSIONS FUND** on behalf of Mamba Ginger Growers Company Limited of Same District in Kilimanjaro Region now invites sealed Tenders from eligible Manufacturers (**NOT AGENTS**) for carrying out the Supply, Installation, Testing and Commissioning of Ginger Factory Machinery & Equipment at Mamba Miamba Ginger factory in Same District.
